This is an increase on last year's figure of 1.386 and places the journal among the highest ranked journals globally in the Agricultural Economics & Policy category (9/33) and is a very strong placement within Economics category (115/549). AARES 2022 Conference Workshops Call for Submissions

Submissions are encouraged on any topic that is relevant to agricultural, resource, environmental, energy, or development economics. Workshops that involve some form of training are also welcomed. Proponents are encouraged to consider topics which would be suitable for delivery online via live-streamed sessions. Workshops can take between 1 and 5 hours and can be organised in single or multiple sessions. They can involve a single presenter or a group of presenters. Proponents are asked to indicate whether the workshops will be free of charge to registered participants (participants to the workshop do not necessarily have to attend the main conference) or whether a registration fee will be required (indicative amount should be nominated in the proposal).

Proponents are also asked to indicate their preferred option for the event:

- · in-person in Sydney, or
- in virtual format.

Organisers of workshops are encouraged to:

- design the event to attract current and new members (private/industry/government)
- include people from government, industry or other disciplines as speakers and participants
- approach sponsor to meet any costs involved in the workshop, such as the cost of bringing in a high-profile speaker
- promote their event, to help raise the profile of the conference and the Society.

Workshop Format: Detail the format of the workshop, including time allocated to each presenter, whether there will be a discussion panel, who will be the chair, and so forth. For example, identify whether the session entails a set of speakers presenting papers on the designated theme, several "headline" speakers and selected discussants, short presentations from a panel of speakers followed by a general discussion or a Q&A session, or some other configuration. Approaches that differ from a set of standard conference presentations are encouraged. Please mention if there is any specific technical need or training component. It is especially important that you take into account your preferred format (online or in-person) when addressing this last requirement.

Conference Theme, Guest Speakers and Panel Sessions

The theme for the 2021 NZARES conference is "What's next for the Primary Industries?" and the Key Note Speaker for the conference will be Professor Nicola Shadbolt from Massey University who has vast experience as a farmer, forester, director and academic. She is currently the chairperson of Plant and Food Research and member of the Climate Change Commission.

There will be three panel sessions on important topics and con-current contributed paper sessions on various themes:

- The "Impacts of Covid-19" panel will provide an update on New Zealand's recovery and the prolonged impacts on the primary industries and supply chains as Covid-19 continues to shape how we live in 2021.
- The "Sustainable, Innovative Agriculture" panel will focus on regenerative agriculture to provide an update on what it is all about and a vision for Regenerating Aotearoa New Zealand.
- A panel on the Climate as the Climate Change Commission. The commission has recently released its final report outlining a way towards a carbon neutral future. This session would focus on what primary industries can do to reduce emissions, what the potential impacts will be, and an update on the He Waka Eka Noa Primary Sector Climate Action Partnership.



AARES - Crawford Fund Award

Call for Submissions

Purpose

The Australasian Agricultural and Resource Economics Society (AARES) will facilitate the attendance of one AARES scholar (normally a PhD student or an early career researcher) at the <u>Annual Crawford Fund Conference</u> to be held in Canberra on the 13-14th of December 2021. The purpose of the grant is to encourage scholars to build networks and skills, and to facilitate contact and discussion among those studying the problems or extending



knowledge of agricultural and resource economics. Award recipients are encouraged but not required to present a paper at the conference.

Amount of Award

AARES will provide a grant of up to \$2,000 to substantially meet the costs of online or physical attendance. Funding can be used to pay or remiburse conference registration, a return economy class airfare to Canberra, accommodation for the duration of the conference, and attendance at the Conference Dinner at the Conference. the award will not be held over if the conference is cancelled or the candidate is not able to attend.

Applicants must be members of AARES.

Entries

Entries must be received by **15 September 2021**. Entries are to be submitted electronically to the <u>AARES Central Office</u>, and should include:

- a one-page biographical statement; and

Vale Chloe Munro AO

Ms Chloe Monro AO passed away on the 22nd of June 2021. Her career spanned public service in policy and regulation, tertiary education, the private and not-for-profit sector and she was also a loyal a patron of the arts. She was a leader in the fields of energy, climate change and water, and a mentor and inspiration to many in our profession.

I first met Chloe during her period in the Victorian public service. From 1996 – 2004 Chloe served in the positions of Secretary of

the Victorian Department of Primary Industries and Department of Natural Resources, and Deputy Secretary in the Department of Treasury and Finance where she headed the division implementing Victoria's energy reform and privatisation program.

From 2004 to 2009, Chloe was an executive director of Telstra (2004 – 2009) where she held leadership positions in human resources, business operations, information technology, public policy, communications and customer service and played a significant part in the rollout of multibillion-dollar investments.

Chloe was the Commissioner and Chair of the National Water Commission (2004 – 2012); Chair of AquaSure (2009 – 2012) — the consortium building Victoria's desalination plant and a Non-Executive Director role at Hydro Tasmania (2010 – 2012).

From 2012 – 2017, Chloe was the inaugural chair of the Clean Energy Regulator. After leaving the Clean Energy Regulator in 2017, she worked alongside Australia's former Chief Scientist and Monash Chancellor, Dr Alan Finkel, on the Independent Review into the Future Security of the National Electricity Market. Dr Alan Finkel paid tribute to Chloe as "the intellectual powerhouse who brought discussion threads together through her wit, her experience and her insights born of masters degrees in business, philosophy and mathematics".

Chloe was appointed a Monash Professorial Fellow in 2018. She was a Fellow of both the Australian Academy of Technological Sciences and Engineering and the Institute of Public Administration Australia. Chloe Munro was appointed an Officer in the General Division of the Order of Australia in 2018 for her "distinguished service to public administration through leadership roles in the areas of renewable energy, water and climate change process and reform, and to the performing arts", was included in the Australian Financial Review's 100 Women of Influence 2018 and was awarded the Centenary Medal in 2001.

I will always remember Chloe for her cheerfulness, kindness, compassion and energy and for her strong support for economic thinking applied to government policy. She was an inspiration to me and many other women at a time when women at the top, particularly in her fields of focus, were rare. She has left behind a strong legacy that will not be forgotten.
