He is already busy working as Chair of the Publications Working Party, on our new contract with Blackwells, and will also be responsible for the invited speakers program next year in Canberra. I also would like to thank John Mullen for leading our Society so well over the past year. Thanks also to other members of Council and the executive, and Annie Hurst who runs our central office at ANU. Thanks also to those who gave of their time last year serving on various awards and prize giving committees, and to those serving our Branches. Thanks go to Geraldine Gentle for her work as Manager, Promotion and Development. Geraldine has recently resigned from this position, and we are now advertising for nominations.

You are probably aware that our journal publishers, Blackwell, have merged with Wiley as from last February. We have been assured that it will be 'business as usual' for our Society – editorial office coordinators and journal publishing managers will continue to be located in Melbourne. Wiley and Blackwell are working on how best to integrate their systems for subscription management and online platforms. However 2008 subscription renewals will continue as normal from the Blackwell system and separate online platforms are likely to continue until the end of 2008.

## **AJARE Editors' Report (report to AGM Feb 2007)**

### **New Editors**

The AARES Council has accepted a recommendation for a new editorial team based at the Australian National University: Jeff Bennett, Tom Kompas and Quentin Grafton. The new editors are listed at [http://www.aares.info/office\\_bearers](http://www.aares.info/office_bearers) and [http://www.aares.info/office\\_bearers#Editors](http://www.aares.info/office_bearers#Editors).

Preliminary discussions are underway between the old and new editorial teams about transition arrangements for early 2007 regarding the management of existing and new submissions to AJARE. The new editors will be responsible for Volumes 52 – 54.

### **State of the Journal**

The flow of submissions is continuing at a favourable rate. In 2005 the journal received 120 submissions and in 2006 125 submissions were received. Compared with earlier years (see attached table) AJARE is receiving an enhanced number of submissions. We realise that this places increased demands on reviewers and associate editors and the AJARE editors are genuinely thankful for the support they continue to provide.

The following summary statistics from January 2007 were generated by the Manuscript Central web site.

In June 2006 the 2005 impact factors of all journals were released and showed AJARE's impact factor had more than doubled, rising 117% to 0.867, up from 0.4 in 2004. In addition, the journal raised its rank in the *economics* subject category from 117/172 to 54/117. In the *agricultural economics and policy* category, the journal moved from 6/8 to 3/9, and was only 5 ranks below the *American Journal of Agricultural Economics* in the general *economics* category.

The 2005 impact factor data is based on cites to articles published in 2003 and 2004 (Chris O'Donnell and John Mullen were AJARE editors then) and it has been noted that AJARE's impact factor has fluctuated over the last few years. Apparently this is normal, and not a cause for concern. What is clear is that AJARE's impact factor is generally increasing over time (see attached chart) and the 2005 impact factor represents the journal's highest ever impact factor.

In September 2006 Thomson Scientific (ISI) announced its acquisition of ScholarOne which provides the electronic editorial office system (Manuscript Central) adopted by AARES for the electronic management of AJARE. Later in November 2006 Blackwell Publishing Ltd and John Wiley & Sons Inc announced their planned merger of both companies. These commercial changes are unlikely to affect AJARE in the short term. The long run implications are less clear. However, greater concentration in the publishing is a common trend.

Issue 3 of Volume 50 was a bumper special issue on "Economic and Policy Aspects of Water Resources". In addition to tributes to the 2006 Distinguished Fellows, it contained 8 original articles, 3 Policy Forum papers, and 2 book reviews. Because the first three issues of volume 50 used up 474 pages of the budgeted 560 pages for volume 50, issue 4 was slimmer, containing only 5 articles and 4 book reviews. In addition, by late January 2007, there are already 6 papers, one note, and 5 book reviews accepted for volume 51, and there are a further 37 papers and one book review in the current workflow. It is likely that we will have accepted enough copy to fill volume 51 before mid year.

Following the successful 2006 IAAE Gold Coast conference, the editors of AJARE tabled a proposal at the September meeting of the Federal Council of AARES for a Special Issue of AJARE on "Developing Country Issues and Applications". This proposal was developed jointly with K. Otsuka, K.P. Kalirajan, and Tom Kompas, to provide an outlet for papers presented at the 2006 IAAE Gold Coast conference, as well as papers submitted in response to a general call for papers on the above theme. The issue would reflect AARES' interest in facilitating growth of the agricultural and resource economics discipline in developing countries.

After discussion, the Federal Council of AARES decided not to proceed with such a special issue, and instead issued a general invitation to all authors of papers presented at IAAE 2006 to consider submitting their papers to AJARE. All such manuscripts will be reviewed in the normal manner, and published in a normal issue of AJARE, rather than in a special issue, if they meet AJARE standards.
