A Word from the President

Dear colleagues,

Welcome to the June issue of News & Views.

As the winter sets in in Canberra, the value of sunshine and outdoor interactions is surely increasing. Many in our community are concerned about the energy bills that will follow and the burden of rising interest rates.

I am writing this while attending a workshop in Kathmandu, where we focus on exploring ideas around policy-research interface and building confidence about influencing change – making policies work better in contexts where market failure is the norm and policy



failures abound. Before arriving here, I also attended a successful branch forum that Sorada's team organised, where we deliberated ways to get more value for the efforts we put in to our strategic planning.

In both forums, the key challenge seems to be around translating a vision into actions that lead to measurable outcomes. My feeling is that it all relates to mechanism design and organisational settings that facilitate the mechanisms being used to achieve the outcomes sought. Then, partly, the failure to achieve the desired influence on behaviours that lead to change relates to inappropriate vision and partly to the organisational setup – including the structures and processes of governance and the metrics that informs the effectiveness of delivery – in meeting what was planned.

During our deliberations in Kathmandu, we garnered the view that much of the organisational and delivery constraints affecting public policy in the agricultural sector in South Asia are related to the conflict between private and public interest. It is fostering a state of fragility and contributing to despair and distress. It was also evident that systems that were developed to help build resilience are now proving to be a part of the problem. Finding ways to move out of the trap surely involves giving voice to the people who are voiceless, and building capabilities to relieve the burden of past mistakes and enhancing choice sets that take advantage of local comparative advantage, in seeking ways to assure basic consumption needs.

Over the next 6-8 weeks, as we bring our ideas together to create a meaningful strategic plan for AARES, it is our opportunity to see how we can empower and enable the members of tomorrow and give a meaning to what we do as a learned society.

I hope this note inspires you to have a closer look at the AARES constitution and evaluate if you agree with the vision, objectives, and goals that were set in the past, and what might suit better for the times we are heading over the next five years and beyond. Do you agree we have the right organisational structure and processes to back in doing our voluntary work? Your feedback and suggestions will help us narrow the vision-practice gap that we all agree will help us maximise our collective interests.

The Research Fellow will undertake research to determine the non-market benefits of coastal and inland wetland restoration and quantify people's willingness to pay for goods and services provided by wetlands. The appointee will test market designs for blended finance by assessing the suitability of various financial mechanisms (biodiversity credits, reverse auctions, covenants, tax breaks or carbon credits) that could incentivise private landowners to restore coastal and inland wetlands to sequester carbon and reduce greenhouse gas emissions. The appointee will undertake a cost-benefit analysis, including financial and economic assessments incorporating non-market values and 'willingness to pay'. This work aims to deliver a business case to guide policymakers/land managers in the design of restoration programs for coastal and inland wetlands.

The AARES QLD Branch organised a symposium on the 27th of April 2023. Three speakers were invited.


Emma Comerford (Principal Economist, QLD Government, Dpt. of Environment and Science), who has been a regular of the Branch's symposia for many years, gave the audience a snapshot of her work as an economist within her government department. It was really informative and refreshing to learn about the work being done "behind the scenes" on the policy side, and the many challenges Emma encounters daily communicating economics to colleagues from different fields of expertise.





Bernardo Cantone (CERC Postdoctoral Fellow, CSIRO) was the second speaker. He presented his captivating research on carbon pricing and green innovation in the European Union, exploring the correlation between carbon prices and patents for low carbon technologies.

Finally, <u>Shabbir Ahmad</u> (Research Fellow, UQ) presented his interesting work on agricultural productivity growth in different agro-climatic zones of Pakistan, stressing the influence of technology adoption, improved resource allocation and climatic factors on productivity.



With a total of 25 participants (20 in-person, 5 online), it was the largest turnout ever recorded by the Branch for this kind of event! This is extremely encouraging to see the AARES QLD community expand and become more interactive year after year. There will certainly be another symposium in the second part of the year, although time and location are still to be defined.

In memoriam

Vale Euan Maclean Fleming 1945-2023

It is with deep sadness that we share that Euan Maclean Fleming, 2018 AARES Distinguished Fellow and Emeritus Professor in the UNE Business School, recently passed away on 30 April 2023. His death notice can be found <a href="https://example.com/here/bellow-new-market-new-ma

Euan made many distinguished academic and service contributions to AARES over many years after being elected as the inaugural Vice President of the New England Branch in 1977-78 and then President in 1978-79. These contributions ranged from chair of the Postgraduate Thesis Award committee, associate editor of AJARE, several further terms as President and/or Secretary of the Branch, and service on various committees including several LOCs. Euan attended and presented at numerous AARES conferences and was especially respected for his generous and influential contributions to research discussions.

Euan retired from his substantive position at UNE in 2014, after a significant career spanning 33 years during which he contributed particularly to the discipline of Agricultural and Resource Economics and as Head of the School of Economics. Euan was immediately bestowed with the title of Emeritus Professor in the newly formed UNE Business School. He had a distinguished profile in research, teaching and learning, post-graduate supervision, and administration. Post-retirement and until very recently, Euan engaged in collaborative research activities internationally and joined his colleagues for robust morning tea discussions about research and current affairs.

Euan's appointment citations as <u>AARES Distinguished Fellow</u> and <u>UNE Emeritus</u> <u>Professor</u>, and his <u>UNE staff profile page</u>, detail his significant career.

An obituary is being prepared for publication in AJARE in due course, by colleagues who enjoyed close professional and personal relationships with Euan.
